INSTRUCTIONS

The original and 5 copies of the completed application must be filed with the Commission along with a filing fee of \$25.00 by check or money order payable to the N. C. Dept. of Commerce/ Utilities Commission. Applications may be mailed to the North Carolina Utilities Commission, 4325 Mail Service Center, Raleigh, North Carolina 27699-4325 or filed in person at the Chief Clerk's Office, Room 5063, Dobbs Building, 430 N. Salisbury Street, Raleigh, North Carolina.

Upon receipt of the completed application and required filing fee, the application will be scheduled for public hearing. Notice of the application and hearing date will be mailed to all licensed brokers. Any protests to the application must be filed with the Commission at least ten (10) days prior to the hearing date. If no protests are filed, the hearing will be cancelled. The Applicant must then submit affidavits or notarized letters of support from groups or individuals who desire the services of the Applicant as a broker. The Applicant must also submit an affidavit or notarized letter attesting to his/her fitness and ability to provide the proposed service and that the Applicant will only engage those motor carriers authorized by the Commission to transport passengers by motor vehicle within North Carolina. If protests are filed, the hearing will be held as scheduled, and the Applicant must present witnesses to testify in support of the application.

Upon approval of an application for broker's license and prior to providing service, a bond in the amount of not less than \$5,000 must be filed with the Utilities Commission to insure the financial responsibility of the broker and the supplying of authorized transportation in accordance with agreements, contracts, and arrangements therefore.
